#### Explanation of Responses:

1. The Series X Convertible Preferred Stock ("Series X Preferred") is convertible at any time at the holder's election and has no expiration date. All shares of Series X Preferred, including all accrued and unpaid dividends thereon, will be automatically converted on a 4.05783-for-1 basis into shares of Common Stock upon the closing of the Issuer's initial public offering. The number of shares of Common Stock as shown in column 3 is based on a conversion of 431,432 shares of Series X Preferred.

2. These options are fully vested.

3. These options shall vest 25% on August 29, 2015, and the remainder shall vest in equal monthly installments thereafter over 36 months, provided, that no portion of this stock option shall become vested and exercisable until the consummation of the issuer's initial public offering.
